#### **Appetizers:**

Finger Food Only - Items must be cooked onsite but do not have to be cooked on a pit.

#### **Ribeye Steak:**

Steaks will be turned in whole and table captains will slice. Remember steaks should be cooked medium-rare to medium (130-145 which is pink in the middle). Steaks should arrive unmarinated. Marinating can begin after meat inspection which will start at 1:00 pm on Saturday.

\*\* **Absolutely NO** Load-In prior to 9:30 am - This is a City Requirement. Event organizers will be onsite at 9:30 to organize load-in.

\*\*\* **EVERY** team must have a 2A 40BC or 3A 40BC fire extinguisher with a current inspection tag or a current receipt. Current is less than 1 year old! Seattle Fire Department personnel will be onsite to perform inspections. Check your fire extinguisher before arriving! No fire extinguisher, no cooking!

**We are working with the City of Seattle to have power provided, but this is not yet confirmed. If you require power, be prepared with a generator (Quiet Generators Only!) or other power source.**
