#### Sausage and Chicken Wings

Six individual pieces must be turned in.

The ribeye steak may be bone-in (a Cowboy Ribeye) or bone-out and must weigh between 10 oz and 16 oz. The whole steak will be turned in; it will be cut at the judging table after the presentation score.
