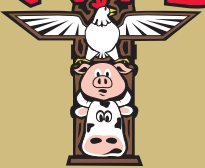

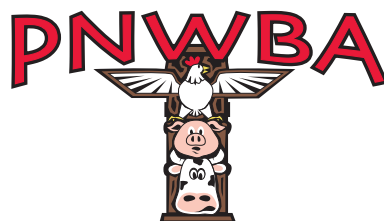

Sauce Rules:

Teams who enter must have made their own sauce. If you have a commercial sauce that you created you can submit that as an entry. Teams will be provided a cup for turn-in.

Dessert Rules:

Teams must make 80% of the Dessert onsite. Can be cooked on your BBQ, over propane in a dutch oven... all is ok as long as it is prepared and cooked at your tent onsite. For example: if you are making a cake you must cook it onsite! or if you made a pie.. you could prep the pie dough at home but cook on your BBQ onsite. Teams can use their own tray we ask that you keep the tray size down to no larger than 15 x 13.
